## Executive Summary

The present document aims at defining the health economic protocol that will be used in order to collect all the information to perform the economic evaluation of the CAREPATH-intervention. Therefore, it will collect information on patients and family caregivers for those receiving care at baseline, at 6 months and at 12 months. This information will be focused on sociodemographic characteristics, time of care, caregiver work status, caregiver health care utilization and possible problems suffered due to the care they provided.

For this purpose, the economic evaluation to be carried out in the CAREPATH project would estimate the incremental cost-utility ratio and incremental cost-effectiveness ratio in order to reveal the incremental cost (or the potential savings) per unit of benefit of switching from usual care to CAREPATH-an integrated patient-centred approach- in multimorbid elderly patients with dementia.
